The 2022 Inflation Reduction Act (IRA) had promised generous, decade-long tax credits for clean energy (including a 30% credit for home solar installations). However, a mid-2025 budget law – officially the One Big Beautiful Bill Act (OBBBA) – rolled back many of these incentives.
