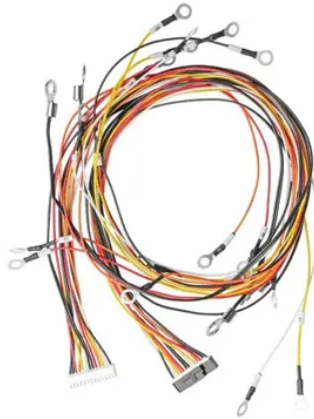




# What qualifications are required for industrial and commercial energy storage EPC

You must have an EPC if: 1. you rent out or sell the premises 2. a building under construction is finished 3. there are changes to the number of parts used for separate occupation and these changes involve providing or extending fixed heating, air conditioning or mechanical ventilation systems You must display an EPC by fixing it to your commercial building if all these apply: 1. the total useful floor area is over 500 square metres 2. the building is frequently visited by the public 3. an EPC has already been produced for the. You do not need an Energy Performance Certificate (EPC) if you can demonstrate that the building is any of the following: 1. listed or officially protected. You need to arrange a property assessment to get an Energy Performance Certificate (EPC). Find a commercial energy assessor. The type of assessor you'll need will depend on the complexity and features of the. You can ask for a review if you get a penalty charge notice. The notice will tell you how to do this. If the review fails, you'll get a letter confirming your penalty. You can then appeal to the county court (or sheriff court in Scotland).

Requirements

Any commercial sales or letting advert for a building must include the EPC rating, or "energy performance indicator". This must also be provided to anyone to enquires about buying or leasing the building. For a home or domestic building, this is the Energy Efficiency Rating. For a non-domestic building, this is the Energy Performance Rating.

MEES requirements for commercial property owners

With the UK government tightening Minimum Energy Efficiency Standards (MEES) for commercial properties, landlords face new requirements by 2027 and 2030 om 2028, non-domestic properties in England and Wales must achieve an Energy Performance Certificate (EPC) rating of at least C to remain eligible for rental, rising to a B rating by April 2030.

In fact, it has been compulsory for commercial landlords to offer an EPC free of charge since 2012, aside from a few exceptional circumstances where an EPC is not required (existing EPC exemptions are listed below) you could be fined up to £5,000 if you do not make an EPC available to the prospective buyer or tenant as a commercial landlord.
